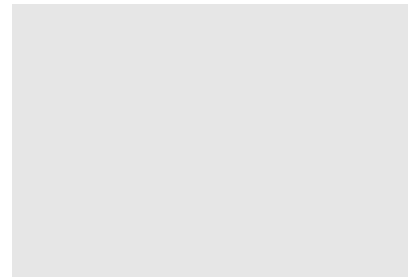
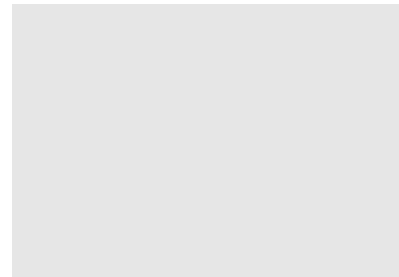


Decriminalize marijuana for medical purposes through administrative action

Establish national use of force standard

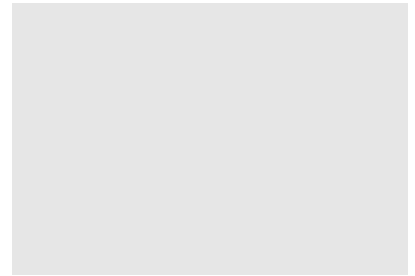

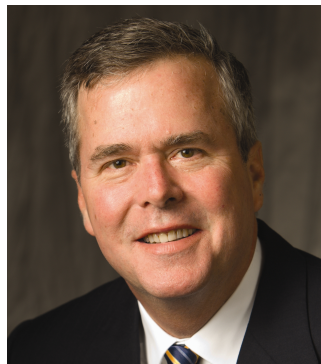
<b>DEMILITARIZATION</b> 		<p>“Demilitarize our police forces so they don’t look and act like invading armies.”</p>	<p>Ban police agencies from using federal funds to buy military equipment</p>
<b>COMMUNITY REPRESENTATION</b> 		<p>“We need police forces that reflect the diversity of our communities”</p>	
<b>BODY CAMS / FILM THE POLICE</b> 	<p>Create national standards for the use of body cameras</p>	<p>Federally fund and require body cameras for law enforcement officers</p>	<p>Mandatory body cameras for police officers</p>
<b>INDEPENDENTLY INVESTIGATE &amp; PROSECUTE</b> 	<p>Lower the standard of proof for Department of Justice investigations of officers</p> <p>Legislation to encourage states to appoint special prosecutor on police killings</p>	<p>Department of Justice must “aggressively” investigate and prosecute police officers who break the law and hold them accountable for their actions</p>	
<b>COMMUNITY OVERSIGHT</b> 	<p>Use federal funds to encourage “empowered” civilian review boards</p>	<p>Use federal funds to encourage “increased” civilian oversight of police departments</p>
